**ONE PERCENT (1%) SALES AND
USE TAX WITHIN THE CITY OF
HARTFORD, ARKANSAS**

Ordinance NO. 2015-09-28

Under the authority of the Authorizing Legislation, there is hereby levied a one percent (1%) tax on the gross receipts from the sale at retail within the City of all items which are subject to the Arkansas Gross Receipts Act of 1941, as amended (Ark. Code Ann. §26-52-101, et seq.), and the imposition of an excise (or use) tax on the storage, use, distribution or other consumption within the City of tangible personal property subject to the Arkansas Compensating Tax Act of 1949, as amended (Ark. Code Ann. §26-53-401, et seq.), at a rate of one percent (1%) of the sale of the property or, in the case of leases or rentals, of the lease or rental price (collectively, the "Sales and Use Tax").
