The Sebastian County Election Commission, pursuant to Arkansas election law 7-5-202, does hereby proclaim that a Special Election will be held on Tuesday, May 12, 2015. Voters can find their polling place at [www.voterview.org](http://www.voterview.org). Questions concerning voter eligibility, changes to voter's registration or those that do not have access to the internet, please call the County Clerk's office at 479-782-5065 **prior to Election Day**. Voters will vote on:

**QUESTION 1:** Continuation of a One Percent (1%) local Sales and Use Tax within the City for streets, bridges, and associated drainage.

**QUESTION 2:** If the tax in Question 1 is approved, may Five Percent (5%) of the revenue be used for trails and bikeways?

**ABSENTEE VOTING:** County Clerk's office, Sebastian County Courthouse (Fort Smith) March 26, 2015 – May 11, 2015. Absentee ballot processing will begin at 9:30 a.m. on Election Day (May 12, 2015) in Room G-8 of the Sebastian County Courthouse, Fort Smith, Arkansas.

**EARLY VOTING:** Room G-8 at the Fort Smith Courthouse.

Tuesday, May 5 – Monday, May 11, 2015, 8:00 a.m. – 5:00 p.m. Early voting closes at 5 p.m. May 11, 2015.




