

**PROCLAMATION
FORT SMITH SCHOOL DISTRICT NO. 100
SEBASTIAN COUNTY, ARKANSAS**

In accordance with the provisions of Arkansas Code Annotated (6-14-109) notice is hereby given that the annual school election in the Fort Smith School District will be held on Tuesday, September 16, 2014, for the following purposes:

To elect two members to the Board of Directors, one for Position 2 At-Large for a three-year term, the other for Position 7, Zone III for a three-year term.

To submit the question of voting a total school tax rate (state of local) of 36.5 mills on the dollar of the assessed value of taxable property located in this School District. The proposed tax includes the uniform rate of tax of 25.0 mills (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. The total proposed school tax levy of 36.5 mills includes 25.0 mills specifically voted for general maintenance and operation, and 11.5 mills for debt service previously voted as a continuing levy pledged specifically for the retirement of bonded indebtedness. The entire 11.5 existing debt service mills will be a continuing debt service tax until the retirement of all bonds. The surplus revenues produced each year by the debt service millage may be used by the District for other school purposes.

The total proposed school tax levy of 36.5 mills represents the same rate presently being collected.

In accordance with the provisions of Arkansas Code Annotated [6-14-102(c)(1)], the polls will not be open on election day. All balloting will be by absentee and early voting.

Absentee ballot processing will begin at 6:00 p.m. on Election Day (September 16) in the County Clerk's Office of the Greenwood Courthouse.



GREENWOOD SCHOOL DISTRICT NO. 25
SEBASTIAN COUNTY, ARKANSAS**

In accordance with the requirements of Arkansas Code Annotated (6-14-109), notice is hereby given that the annual school election in the Greenwood School District will be held on Tuesday, September 16, 2014, for the following purposes:

To elect two members to the school board, one to fill an five-year term for Position 4, the other for a five-year term in Position 7; and

To submit the question of voting a total school tax rate of 40.6 mills on the dollar of the assessed value of taxable property located in this School District. The total proposed school tax levy of 40.6 mills includes 25.0 mills specifically voted for general maintenance and operation, 13.7 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness and 1.9 new debt service mills. The 1.9 new debt service mills plus the 13.7 existing debt service mills now pledged for the retirement of existing bonded indebtedness, which debt service mills will continue after retirement of the bonds to which now pledged, will be a continuing debt service tax until the retirement of proposed bonds to be issued in the principal amount of \$10,000,000, and which will mature over a period of 30 years and will be issued for the purpose of erecting and equipping new school facilities and renovating and equipping existing facilities. The surplus revenues produced each year by the debt service millage may be used by the District for other school purposes.

The total proposed school tax levy of 40.6 mills represents a 1.9 mills increase from the rate presently being collected.

Absentee ballot processing will begin at 6:00 p.m. on Election Day (September 16) in the County Clerk's Office of the Greenwood Courthouse.
