

To submit the question of voting a total school tax rate of 38.0 mills on the dollar of the assessed value of taxable property located in this School District. The total proposed school tax levy of 38.0 mills includes the uniform rate of tax of 25.0 mills (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 38.0 mills includes 25.0 mills specifically voted for general maintenance and operation and 13.0 mills voted for debt service. The 13.0 debt service mills will be a continuing debt service tax until the retirement of all existing bonded indebtedness. The surplus revenues produced each year by the debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 38.0 mills represents a 1.3 mill decrease from the rate presently being levied for the electors in the former Hartford School District No. 94 of Sebastian County, Arkansas and the same rate for the remaining electors in the District.




